RMP during COVID-19 Summary for SCACASA update

Carlos,

Below is the summary you requested.

For the 2020-2021 RMP renewal season, we tried to engineer the desired outcome: to issue time-specific and site-specific permits for the use of restricted materials that meet all pesticide regulatory program mandates while ensuring the safety of our staff and that of industry. Carlos would keep the ag industry informed of our ongoing and developing procedures by providing updates to Farm Bureau, Veg Growers, CAPCA, and other ag advocacy groups.

We began the remote permit review by sending authorized reps their current permits for revision and accepted permits from the industry by mail, email, dropbox etc. We then logged received permits and determined an "effort quotient" based on CalAgPermits data, which we used to decentralize review duties by assigning permits to individual staff vs. the traditional "grab-as-you-go" approach. We allowed staff to take many permits home and developed a permit tracking system. We developed internal standardized site maps using ArcGIS Pro and made them accessible through Microsoft Teams for staff to use when reviewing sites. These maps are based on existing sensitive site data, including residential areas, cities, schools and daycares, populous industrial areas, international border, etc. This allowed for consistency amongst staff review of sites and surroundings and allowed for greatly expedited permit review. Once we had received and entered 65% of all expected permits, we shifted staff from "review" to "signing" duties. We used a shared Outlook appointment calendar to schedule and organize appointments with permittees and utilized our administrative professional's division to make "signing" appointments. This calendar helped us avoid double booking the lobby as we only allow a single member of the industry or the public into the building at a time. We also used this system to administer PAC exams. We encouraged staff to push for RMP signing interviews virtually or by phone. PUE staff would then email/fax etc. the permit and conditions to the permittee, and then the permittee would return the signed documents. Remote signing does place a greater burden on staff to followup with signed documents. For those companies with DocuSign, signing permits was very efficient and effortless.

These are the programs and technologies that we incorporated to renew permits during COVID-19:

- Zoom used for weekly meetings to check in with staff and get feedback on what processes were working and provide important safety updates
- Microsoft Teams (free version) hosted our permit tracking log, ArcGis maps and used to share ideas,
 relevant files and for training
- Arc Gis Pro used to create unique maps for each site
- Virtual Private Networks for staff very helpful for developing "virtual workplace" and "work from home" guidelines
- Overtime
- Explored possibility of electronic signatures with DocuSign

- Briefly hosted an appointment calendar plug-in on our website, which we abandoned for the Outlook calendar due to the limited details available when an appointment is made (only the name and time are available). I understand this is because PUE has heavy restrictions using the website
- Revamped our two conference rooms into two virtual meeting rooms equipped with a big-screen television, web camera, microphone, microcomputer, wireless keyboard and mouse

LATEST NEWS AND INFORMATION

<u>Senate Rules Committee - Confirmation Hearing for Director of DPR</u>: DPR Director Val Dolcini's confirmation hearing before the Senate Rules Committee took place on August 5th. The Senate Rules Committee voted unanimously to recommend support for his confirmation on the Senate Floor. In order for Director Dolcini to be confirmed, a vote by the Senate will be required.

Citrus/Bee Protection Areas: Existing regulations are currently outdated and unclear. Portions of these sections are outdated regarding their limited options for use of modern communication (Notification to Beekeeper), especially in light of AB 2468 (Requires beekeepers to notify the CAC of movement between counties). Additionally, the proposed changes will align the regulations with federal labeling language and FAC requirements, and eliminate duplicate or unclear regulations within the Pesticide Toxic to Bees (6650) and Citrus/Bee Protection Areas (6656) sections. Furthermore, proposed changes include making section 6655 inoperative, allowing the new Bee Where software program to streamline the notification process for applicators, apiarists, and county agricultural commissioner's staff associated with the services provided by existing section 6655. The intent of these regulations is to provide clarity to the regulated community and assist enforcement with its important requirements. DPR anticipates noticing these regulations in late summer 2020.

Carbon Monoxide Devices to Control Burrowing Rodents: Senate Bill 1332 was approved in 2014 and became effective January 1, 2015. This law added FAC sections 14160 and 14161, requiring the Director to regulate the use of carbon monoxide pest control devices for burrowing rodents. Currently, other than device labeling requirements specified in FAC section 6025.4, there are minimal requirements controlling the sale and use of these devices. Additionally, as these devices are not pesticides, many existing regulations do not apply when using a carbon monoxide generating device. The proposed regulations are intended to ensure that carbon monoxide devices are used in a safe and effective manner. Also, the proposed regulations will add requirements for employers and prohibitions around sensitive areas. DPR anticipates noticing these regulations in late summer 2020.

<u>Pesticide Decontamination Sites</u>: The proposed regulations will amend requirements for pesticide handler decontamination facilities, improve eyewash regulation compliance, and clarify language that mention eyewash equipment. This proposed action will require employees that handle specific categories of pesticides to have access to an eyewash station that meets the requirements found in the American National Standards Institute (ANSI) Z358.1-2014 standard. In addition, the proposed action will require a decontamination site to be available to all employees handling pesticides for non-agricultural uses regardless of the pesticide toxicity category. DPR anticipates noticing these regulations in fall 2020.

ENFORCEMENT BRANCH

New Carbaryl Regulations – Effective August 1, 2020, all carbaryl products available to the general public (by retailers) became California restricted materials. Amendment to CCR 6400(c) and (e)4 removing the exemptions means that retailers and unlicensed individuals (including homeowners) cannot sell or possess carbaryl products. The agricultural use baits are unaffected. For more detail, see recently issued ENF 2020-10 Letter to CACs. There is also a DPR May 12, 2020 outreach notice of new restrictions about product sales, product use, licensee requirements, and who to contact. Product Compliance Inspections: Staff continues to conduct Marketplace Surveillance Inspections (MSI) at pesticide retailers and distributors statewide. The focus of these inspections is to ensure that products offered for sale are properly labeled and are registered both federally and with the state. MSIs are currently being conducted online. Additionally, Producer Establishment Inspections (PEIs) are conducted on behalf of the U.S. EPA at pesticide producing facilities throughout the state. Due to COVID-19, no PEIs were conducted in July. Any product compliance issue (unregistered/misbranded products) found by CACs can be forwarded to the Product Compliance Unit at productcompliance@cdpr.ca.gov.

<u>Structural Pest Control Training</u>: The next Structural Pest Control training for CAC inspector staff is being planned for fall of 2020. It won't be an in-person training, but will be a virtual training, most likely a 2-day session using on-line presentations and interactive online breakout sessions. More details to come in the next few months.

<u>CalEPA Basic Inspector Academy (BIA) Training:</u> Due to COVID-19, all in-person CalEPA BIA training courses have been cancelled. CalEPA is in the process of developing a virtual training but most likely it will not be ready to launch until early 2021. If you have any new staff that need training please consider having them complete the online Fundamental Inspector Course. This

class is also a prerequisite for attending the BIA. The online Fundamental Inspector Course provides an overview of CalEPA Boards and Departments, local agencies, environmental law, environmental science, the role of the environmental inspector and basic field health and safety. Although the course was designed for new environmental inspectors, members of the public may also find this training helpful. You are welcome to view this self-directed online training for your own benefit. To register, you must create an account on <u>ARB's training website</u>.

Enforcement Branch Updates to the DPR External Web Site (www.cdpr.ca.gov):

• At various locations on the DPR web site, staff contact information is being updated to reflect the new locations of the Headquarters and Northern Regional Offices.

Licensing Unit - Licensing Exams: July 2 was Licensing's first day referring individuals who have been waiting to take pest control exams using the new contractor, PSI, to take electronic exams at testing centers statewide. Licensing approved and referred 174 individuals who needed to take Category A, Category D, and QAL Laws & Regulations exams. The first 174 individuals will account for around 330 actual exams. These exams were prioritized due to these license categories being necessary for sanitation pest control, plant commodity agriculture pest control, and the importance of Category A and D to human health and our food supply. The PSI system emailed applicants instructions on how to schedule their exams. The applicants will have the ability to take proctored exams at approximately 20 different locations throughout the state. PSI is also working to greatly increase the number of exam sites beyond the current 20. We will continue to approve and forward names of individuals for exam scheduling to PSI as more license categories become available in the PSI system. We will continue to work with PSI and prospective licensees to schedule exams for other categories as they become available.

<u>Early Renewal Notices</u>: June 15, early renewal notices were mailed to new license and certificate holders with surnames A-L that received their license/certificate earlier this year, who may have completed their required continuing education hours, and to Dealer Designated Agents who do not have required CE. In an attempt to avoid the end of the year bottleneck, we have mailed out early renewal notices to 5,519 individuals fitting these criteria. Early renewal notices were also mailed to 103 A-L businesses that hold Pest Control Broker licenses.

<u>CLas-positive ACP</u>: An Asian citrus psyllid (ACP) sample - confirmed positive for *Candidatus Liberibacter asiaticus* (CLas) the bacteria that causes Huanglongbing (HLB) - was collected from a commercial citrus grove in the Woodcrest area of Riverside County. Confirmed by the Citrus Research Board's laboratory, this single adult psyllid is the first CLas-positive ACP found in a commercial citrus grove in California. https://citrusinsider.org/2020/08/07/clas-positive-asian-citrus-psyllid-found-in-riverside-commercial-grove/

Canines Detect HLB: To identify HLB infected citrus trees and prevent a mass epidemic, the Ventura County Farm Bureau hired detector dog teams specially trained to find HLB bacteria. The teams ultimately identified over 200 infected trees in a grove of 3500. The canine-detection method was validated in blind tests by USDA Agricultural Research Service in collaboration with CDFA, with results published in 2020. https://www.pnas.org/content/117/7/3492

<u>Organic Enforcement</u>: USDA-AMS-National Organic Program proposed rule to strengthen oversight and enforcement includes: applicability of the regulations and exemptions from organic certification; National Organic Program Import Certificates; recordkeeping and product traceability; certifying agent personnel qualifications and training; standardized certificates of organic operation;

unannounced on-site inspections of certified operations; oversight of certification activities; foreign conformity assessment systems; certification of grower group operations; labeling of nonretail containers; annual update requirements for certified operations; compliance and appeals processes; and calculating organic content of multi-ingredient products. <u>Neonicotinoids</u>: USEPA seeks public comment on a petition by the Natural Resources Defense Council dated 5/2/2020, to revoke all tolerances for the neonicotinoid pesticides acetamiprid, clothianidin, dinotefuran, imidacloprid, and thiamethoxam on raw agricultural commodities; to cancel all uses for which risks of concern cannot be mitigated; and opposing the USEPA interim registration review decisions which would permit their continued use.

Preharvest Ag Water Antimicrobial Treatment: Currently no registered antimicrobial treatment products are authorized to control microorganisms of public health significance for use on agricultural fields, or for treatment of irrigation water systems or ponds. In support of USFDA's 2020 Leafy Green Action Plan, USEPA and USFDA developed a testing protocol for registrants to develop data on the effectiveness of products to inactivate pathogens in preharvest agricultural water to support registration of new treatment products or amendments to current product labels. http://s2027422842.t.en25.com/e/es?s=2027422842&e=357885&elqat=1

<u>Pesticide Use Outreach</u>: USEPA grant opportunity for projects promoting safe pesticide use, and implementing the Agricultural WPS and the Certification of Pesticide Applicators regulations. <u>Velvet Long-Horned Beetle</u>: Following a citizen tip in the Porterville/Tulare area, UC Cooperative Extension researchers have installed traps to initiate monitoring for the introduction of the Velvet longhorned beetle, *Trichoferus campestris* (Coleoptera: Cerambycidae), in the southern San Joaquin Valley. HUMAN HEALTH ASSESSMENT BRANCH

<u>Background Information</u>: HHA evaluates the potential health concerns of illegal pesticide residues detected on commodities collected through the Department's food safety program. Branch staff determine whether a case is a potential health concern by conducting a dietary evaluation based on the illegal residue level detected, the consumption rates of the commodity, and the toxicity of the pesticide. Below is a summary of the evaluations the HHA Branch completed for a single case with illegal residues, at the request of the Enforcement Branch, in July 2020. The country of origin is indicated after the commodity name for imported commodities. This case was not found to pose an acute health risk to consumers of the corresponding lot.

CANNABIS AND HEMP UPDATE

<u>Cannabis</u>: On July 28, DPR provided to CACs an enforcement letter outlining changes to DPR's legal use cannabis guidance document and additional changes to its cannabis website. DPR appreciates CAC efforts to submit their remaining cannabis invoices by the end of July. The cannabis program was recently informed that DPR's accounting office had not processed any invoices received in July. It is unclear when processing the invoices will resume but CACs will be notified once this occurs. Approximately \$737,000 in total invoices were received for fiscal year 2019/2020, with one invoice still outstanding and not included in the total.

A revised metrics and justification document for 2020/21 and a revised invoice template were

<u>Hemp</u>: Work continues on a DPR hemp guidance document. DPR continues to monitor state and federal hemp activity. A handful of hemp bills are still making their way through the California legislature. These bills are being monitored by DPR's cannabis staff and its recently hired legislative director. Sponsors are still pushing for state legislation in 2020 that would legalize hemp and hemp extracts, including CBD, to legally be included in edible products.

FDA submitted to the White House in July draft hemp regulations, though details of the regulations are not yet public. The hemp industry has been anxiously awaiting these regulations and are cautiously optimistic that the regulations will permit or provide guidance on CBD in edible products. The lack of regulatory guidance has resulted in significant problems for the hemp industry nationwide. The FDA however, has been unable to provide regulations that would permit such uses because of strict standards identified in the federal Food Drug and Cosmetic Act and the lack of data to safely support such uses.

Mexico's legalization of cannabis and hemp is still slated for passage by the end of 2020 but remains stalled due to Covid. It is thought that this issue is supposed to be taken back up by the Mexican legislature in September or October.

ENVIRONMENTAL MONITORING BRANCH

Edgar Vidrio delivered a technical update about 1,3D mitigation and pilot program to Scientific Review Panel on Toxic Air Contaminants.

Joy Dias, Minh Pham, Maziar Kandelous, Tiffany Kocis, and staff from the Enforcement and Executive Branch met with US EPA to discuss the upcoming US EPA proposals, projects, and grants.

<u>Air Program</u>: Air Program staff collected 24-hr air samples as part of the Air Monitoring Network in Santa Maria, Shafter, and Watsonville.

Air Program staff collected 24-hr air samples as part of the 1,3-D ambient air monitoring study in Delhi and Parlier.

Air Program staff continued to collaborate with DPR's Enforcement and Executive Branches on the proposed 1,3-Dichloropropene mitigation options for the upcoming pilot program.

Air Program staff along with Executive staff met with representatives from Dow and TriCal to discuss the measured included in the proposed 1,3-Dichloropropene pilot program.

Edgar Vidrio, Minh Pham, and Maziar Kandelous presented an overview of Air Program to the audience in WPHA Summer Regulatory Conference.

Minh Pham and Martha Sanchez presented an overview of DPR and Air Program activities to the Eastern Coachella Valley AB617 Community Steering Committee.

<u>Surface Water</u>: Aniela Burant gave a seminar to the Northern California Chapter of ACS on "Protecting Urban Surface Waters from Pesticide Related Toxicity: Science Driven Prevention and Response."

Aniela Burant met with Michelle Andreetta and Courtney Runyun from the Community Integrated Pest Management program to discuss the Bouquet Canyon Creek special study.

Scott Wagner, Xin Deng, and Emily Edgerton collected surface water grab samples from sites in Butte, Colusa, Merced, Stanislaus, and Yolo Counties for the Northern California agricultural monitoring study.

Scott Wagner, Xin Deng and Anson Main participated in a conference call with the San Luis Resource Conservation District about a collaborative pesticide mitigation project.

<u>Groundwater</u>: Groundwater staff collected groundwater samples in various communities throughout the San Joaquin Valley as part of its Well Monitoring Network.

Several GWPP staff met with staff from the Central Valley Regional Water Quality Control Board's Irrigated Lands Regulatory Program to provide overviews of our programs, talk about how to facilitate better coordination, and arrange more regular meetings between our two programs.

INTEGRATED PEST MANAGEMENT BRANCH

CA Grants Portal Launch Webinar: July 1, Tory Vizenor and Jordan Weibel attended a webinar presenting an overview of the California Grants Portal, a funding opportunities portal developed by the California State Library that provides a centralized location for grant seekers to find state grant opportunities. DPR's Grants Team will submit their two opportunities to the funding portal: the Research Grants Program and the Alliance Grants Program. The California Grants Portal will publicly launch on July 15 and will be useful in raising awareness of these two grants programs.

Research Grant Meeting: July 2, Matt Fossen and Rodney Jones met with Dong-Hwan Choe and Paige McGee of UC Riverside to discuss budget changes to DPR research grant 18-PML-R003 ("Reducing risks associated with fumigation by improving current heat treatment and localized treatment technologies") as part of a proposed grant amendment.

Efficacy and optimal use of alternatives to chlorpyrifos for aphid and whitefly management in cotton (Research Grant): July 6, Tory Vizenor and Dr. Ian Grettenberger (Lead PI, University of California Cooperative Extension) met virtually to discuss the development of the grant agreement for this Alternatives to Chlorpyrifos project, which was awarded funding in March 2020. This meeting served as an opportunity to discuss ways to build flexibility into the grant agreement to combat the uncertainty around the effects of COVID-19 on the University of California and agricultural research.

<u>Pesticide Notification Near Schools (Alliance Grant)</u>: July 7, Catherine Bilheimer and Heather Healy (PI, Monterey County) completed the final report for a novel pesticide notification project in Monterey County. Involvement from Agricultural Commissioners, School District Superintendents, Principals and Administrators, and Advocacy Groups was key. A website was created with notification signups, maps of farms within one quarter mile of a school, and

information on health facts and regulations. Farmers and growers were involved through outreach and trainings.

Research Grant Amendment Feasibility Discussion: July 7, Polo Moreno held a conference call with Mark Hoddle, Eamon Keogh, and Shailendra Singh, Co-Principal Investigators of the research grant "To Spray Or Not to Spray? Using Small Cheap IR sensors to Automate Pest Ant Counts". This research grant has been impacted by the COVID-19 pandemic due to ongoing UC Riverside campus closure of their laboratories, as well as sensor components' shipping blocked in China, and lack of access to their field sites. During the conference call, the feasibility of requesting an amendment to extend the project's schedule of deliverables through the end of December 2021 was discussed. The grant's researchers agreed that if conditions allowed, they could complete sensor assembly with parts acquired in the U.S., sensor deployment, and data collection during the 2021 field season from April to November of that year.

Certification Training Assessment Group (CTAG) Remote Conference: July 8, Leslie Talpasanu participated in the monthly CTAG meeting. CTAG consists of state lead agency (SLA), pesticide safety education program (PSEP), and tribal certification program representatives that bring together the best experts in state/federal policy, regulation, instruction, and outreach. CTAG meets to analyze draft policy and regulation/federal standards developed by the United States Environmental Protection Agency (U.S. EPA) and to coordinate state and tribal responses. DPR's participation at CTAG gives California valuable input into the discussion and development of national standards before they become direct regulatory recommendations to U.S. EPA. Nominated issues for CTAG to address include: remote online examinations, online continuing education (webinars and asynchronous), and pesticide label mandated training. Leslie is the lead for the label mandated training requirements workgroup as well as the SFIREG liaison for CTAG.

<u>Oissemination and Training for Citrus Spray Application Expert System Adoption in California (Alliance Grant)</u>: July 8, grant management team members Jordan Weibel, Dr. Peter Ako Larbi (Lead PI, UC ANR) and Dr. Greg Douhan (UC ANR) met virtually for the first annual project meeting. This meeting will be an opportunity to discuss the first project year's progress and activities, as well as make any needed adjustments to the remaining two years of the grant.

<u>Endangered Species Outreach</u>: July 9, Polo Moreno gave a Webinar presentation at the PAPA Zoom Webinar. The title of his presentation was "Endangered Species and Pesticides".

"IPM at Home Healthy Lawn" Video Series: Byron Tam and Pablo Ortiz teamed up from home to produce a series of videos providing IPM tips for healthy and weed free lawns. The video topics include mowing height, addressing rust fungus, dethatching and the importance of mowing with a sharp blade. With many people working from home, these videos provide the public IPM techniques that can be done at home to address and prevent common pest problems for lawns. You can check them out on the DPR YouTube page.

Worker Safety Regulation Work Group (WSRWG) Zoom Meeting: July 13, Leslie Talpasanu presented on new worker safety regulations changes needed to address the federal Certification and Training Rule.

<u>EPA Indoor Air Quality Science Webinar:</u> July 16, Christina Wilkinson attended EPA's Indoor Air Quality Science Webinar titled "SARS-CoV-2 in Indoor Air: Principles and Scenarios Webinar." There is growing evidence that aerosols play an important role in the transmission of COVID-19.

This webinar included a presentation of fundamental principles related to the generation and fate of SARS-CoV-2 in aerosols, with several practical scenarios.

First Annual Meeting for Pest Management Research Grant, "Develop biological control solutions for the management of canker diseases in the fruit and nut crops": July 17, Jordan Weibel met with Dr. Florent Trouillas via Zoom to discuss ongoing progress of Dr. Trouillas' 2019 Research Grant. The discussion included advances towards field trial candidate treatment selection and any needed adjustments to the grant's goals or budget.

<u>First Annual Meeting for Pest Management Research Grant, "Efficacy of Alternatives to Pyrethroids and Neonicotinoids for Aphid Management in Lettuce"</u>: July 17, Jordan Weibel joined Drs. Alejandro Del Pozo-Valdivia and Ian Grettenberger for the annual year-end grant discussion. The meeting focused on lessons learned from the first year of field experimentation as well as technical developments and any necessary changes to ongoing experiments and annual budgets.

Efficacy and optimal use of alternatives to chlorpyrifos for aphid and whitefly management in cotton (Research Grant): On an ongoing basis, Tory Vizenor (Grant Manager, DPR) and Dr. Ian Grettenberger (Lead PI, University of California Cooperative Extension) have been meeting virtually to discuss the development of the grant agreement for this Alternatives to Chlorpyrifos project, which was awarded funding in March 2020. These meetings serve as opportunities to discuss ways to build flexibility into the grant agreement to combat the uncertainty around the effects of COVID-19 on the University of California and agricultural research.

<u>Healthy Schools Act Online Courses</u>: The DPR School and Child Care IPM Program offers free, online courses for stakeholders required to take a Healthy Schools Act course. A total of 30,114 courses have been completed and 5,863 certificates have been issued thru June 2020.

Continued Coordination with California Coastal Commission: July 20, Jordan Weibel, Leslie Talpasanu, and Eric Denemark met again with the informational working group between CDPR, the California Coastal Commission (CCC), and other state agencies. The group continued to discuss coordination efforts with the goal of helping CCC review the City of Malibu's Local Coastal Plan.

Outreach Opportunity Meeting: July 21, Michelle Andreetta and Courtney Runyan from the Community IPM Program and Aniela Burant from Environmental Monitoring met with representatives from the City of Santa Clarita's Stormwater Program to discuss outreach opportunities in support of the Bouquet Canyon Creek Special Study.

<u>CDFA Proactive IPM Program Grant Evaluation</u>: July 21, Matt Fossen met with the grant review committee for CDFA's Proactive IPM program to evaluate the current round of grant proposal submissions.

<u>Endangered Species Project</u>: July 21, Catherine Bilheimer provided Geographic Information System (GIS) map information on endangered, threatened, and rare species in Merced County in response to a request from the county.

<u>Pesticide Applicator Certification and Training (PACT) Webinar</u>: July 23, Christina Wilkinson and Karina Campos attended a PACT webinar titled "Applicator Certification and Training: Antimicrobial/Disinfectants: COVID19 and Beyond." During this webinar a panel of state pesticide

regulators from various regions of the United States discussed how certification and training for application of antimicrobial products are handled in their respective states in response to COVID 19. AAPSE Antimicrobial Workgroup leader Mary Centrella, Cornell Pesticide Safety Education Program Coordinator, discussed AAPSE's current efforts to create a repository for applicator training and other resources focused on antimicrobial and disinfectant information.

<u>CDFA Biologically Integrated Farming Systems Grant Evaluation</u>: July 27, Matt Fossen met with the grant review committee for CDFA's BIFS (Biologically Integrated Farming Systems) program to evaluate the current round of grant proposal submissions.

American College of Medical Toxicology School Reopening Webinar: July 29, Christina Wilkinson attended an American College of Medical Toxicology webinar titled "Reopening Schools During COVID-19." As pressure mounts for schools to reopen this fall, awareness is growing of the need for specific plans on how schools will not just open, but stay open, by protecting the health of children and their families, teachers, administrators and school staff. In this webinar, Founder & Executive Director of the Healthy Schools Network, Claire Barnett, discussed the recently released National Call to Action for state public health agencies to provide all schools an authoritative School Infection Prevention and Control Plan to adopt. She was joined by Allen Barkkume, an Industrial Hygienist who discussed occupational health and indoor air at school.

EPA Indoor Air Quality (IAQ) Webinar: July 30, Christina Wilkinson attended an EPA IAQ webinar titled "Let's Clear the Air: Using Ventilation Practices to Promote Healthy IAQ in Schools." This first webinar of a three-part series presented strategies for operating and maintaining efficient HVAC systems to provide clean and healthy air in schools. Attendees learned how to apply findings from scientific research and guidance on ventilation to reduce the spread of viruses and bacteria using comprehensive IAQ plans and practices. The webinar featured experts, including school district leaders who discussed the plans, practices and principles they have put in place to sustain comprehensive indoor air quality (IAQ) management programs. Each webinar includes a moderated question-and-answer session with speakers and representatives from EPA and the Centers for Disease Control and Prevention (CDC).

REGISTRATION BRANCH

Expansion of Carbaryl's Designation as a California Restricted Material: Effective August 1, 2020, all products containing carbaryl were designated California restricted materials, with the exception of baits labeled only for agricultural use. This expanded designation removes all

previous exemptions to the restricted material designation of carbaryl (except baits labeled only for agricultural use). Additional information regarding this designation, including a list of affected products, can be found under the "Outreach Activities and Materials" section on DPR's Web site at https://www.cdpr.ca.gov/docs/whs/active ingredient/carbaryl.htm>.

California Neonicotinoid Risk Determination and Pollinator Protection Regulatory Action: In July 2018, DPR issued the California Neonicotinoid Risk Determination assessing the risks nitroguanidine-substituted neonicotinoid insecticides (imidacloprid, clothianidin, thiamethoxam, and dinotefuran) pose to honey bees. The determination and its subsequently issued addendum found that crop groups considered to present a risk at maximum annual application levels of at least one of the four neonicotinoids include fruiting vegetables (e.g., tomatoes), cucurbits, citrus fruits, pome fruits, stone fruits, tree nuts, berries, and oilseed (e.g., cotton). DPR scientists reached this determination based on conservative assessments of maximum allowable application rates, and vary according to the neonicotinoid applied. The determination and addendum is available on DPR's Neonicotinoid Reevaluation Web page on the reevaluation of neonicotinoids at https://www.cdpr.ca.gov/docs/registration/reevaluation/chemicals/neonicotinoids.htm.

Legislation requires DPR to adopt control measures to protect pollinator health based on the findings of the determination within two year of completing the determination or provide a status report to the legislature (FAC § 12838). DPR has submitted a report to the legislature detailing our progress towards developing control (mitigation) measures. Part of that progress includes drafting a regulation proposal for agricultural neonicotinoid uses on specific crops and crop groups. Staff are currently assessing the recently completed scientific peer review of the determination to determine if any other considerations should be addressed in the proposal. Additionally, DPR contracted with the California Department of Food and Agriculture Office of Pesticide Consultation and Analysis to provide an economic analysis of various mitigation alternatives, which will soon be posted on CDFA's Web site at https://www.cdfa.ca.gov/oefi/opca/publications.html. DPR has met and continues to meet with stakeholders to learn about commodity cultivation practices and neonicotinoid use patterns in the field and will be conducting stakeholder outreach webinars on August 11 and 12 to discuss the draft regulation proposal and solicit stakeholder feedback. The webinars will be simultaneously interpreted in Spanish. For details on the webinars, please see California Notice 2020-08. Addendum to the 2006 Risk Characterization Document of Sulfuryl Fluoride: In June 2020, DPR finalized its addendum to 2006 risk characterization document (RCD) for the pesticide active ingredient sulfuryl fluoride. DPR will issue a risk management directive if there are exposure scenarios of concern identified by the addendum that require mitigation. <u>Paraquat Dichloride Product Label and Packaging Changes</u>: In accordance with U.S. EPA's December 2016 Paraquat Dichloride Human Health Mitigation Decision, additional labeling restrictions are now required for all end-use paraquat dichloride products. As of November 14, 2019, the following requirements apply to all registered paraquat products:

1) Label changes emphasizing paraquat toxicity and additional supplemental warning materials.

- 2) Restricted Use Pesticide box on paraquat labels must indicate the product is for use only by a certified applicator and is prohibited for use by uncertified persons working under the supervision of a certified applicator.
- 3) All handlers are required to complete a U.S. EPA-approved training program as described on the product label

In addition to these requirements, all end-use paraquat products contained in less than 120 gallons must be packaged in a closed system by December 30, 2020. As of July 31, 2020, DPR has approved three end-use paraquat products that comply with the closed system requirement; DPR is currently reviewing other revised labels that registrants have submitted to comply with this requirement. Existing stock of paraquat products that do not bear the label requirements or packaging specified above can continue to be sold to and used by end-users until such stock is exhausted. Acephate Mitigation Project: In May 2019, DPR issued a Risk Management Directive (RMD) for acephate that identified acute occupational exposure scenarios of concern. These exposure scenarios were initially identified in the 2008 risk characterization document (RCD) and 2013 RCD addendum of acephate. In August 2019, DPR's Human Health Assessment Branch conducted label-specific reviews to determine which registered acephate products bear an exposure scenario of concern. DPR is currently reviewing mitigation options submitted by acephate registrants that may adequately address the concerns identified in the RMD. California Pesticide Electronic Submission Tracking (CalPEST): In June 2019, DPR reinitiated the procurement process for a new contract with a vendor to develop a pesticide registration system that allows electronic submission and processing of applications to register, amend, and renew pesticide products. DPR's Pesticide Registration Branch (PRB) and Information Technology Branch (ITB) staff reviewed and updated the system requirements and developed user stories. DPR included the user stories and updated requirements in a Request for Information (RFI) sent to the vendor community. The intent of the RFI was to gather market data on the potential cost and schedule of the project and solicit feedback on the understandability of the revised requirements and user stories. The RFI was also intended to learn about potential solution options. PRB and ITB have incorporated the feedback received from the RFI responses. PRB and ITB have initiated discussions with the California Department of Technology to begin the next step of the procurement, the development of a request for proposal.

<u>Pesticide Registration Process Workshop 2020</u>: Previously, the Pesticide Registration Branch issued California Notice 2020-04 announcing that the Pesticide Registration Workshop was rescheduled for September 29, 2020. Due to the novel coronavirus, DPR has decided to postpone the workshop to the 2021 calendar year. DPR will be publishing a California Notice with more information soon.

<u>Update on DPR Issued Section 18 Emergency Exemptions</u>: Section 18 Quarantine Emergency Exemption No. 18-07 for Evergreen Pro 60-6 (pyrethrins and piperonyl butoxide) on citrus to prevent the spread of Asian Citrus Psyllid. This emergency exemption expires April 9, 2021.

Section 18 Emergency Exemption No. 20-02 for Firewall 50 WP (streptomycin) on citrus to control Huanglongbing (HLB) has been issued for Imperial, Orange, Riverside, San Bernardino, San Diego, and Ventura Counties. This Section 18 Emergency Exemption is effective from April 7, 2020, to April 3, 2021.

Section 18 Emergency Exemption No. 20-03 for Intrepid 2F (methoxyfenozide) on rice to control armyworm has been issued for Butte, Colusa, Glenn, Merced, Sacramento, San Joaquin, Sutter, Yolo and Yuba counties. An amendment was made to the existing exemption on 7/15/20 to include Placer county This Section 18 Emergency Exemption is effective from 4/20/20 to 10/04/20.

Section 18 Emergency Exemption No. 20-04 for Brigade® WSB Insecticide/Miticide (bifenthrin) on pomegranates to control leaffooted plant bugs has been issued for Fresno, Kern, Kings, Madera, Merced, and Tulare counties. This Section 18 Emergency Exemption is effective from 07/01/20 to 12/31/20.

<u>Update on Section 24(c) Special Local Need (SLN) Registrations</u>: The Department issued a third-party SLN CA-200006 to the Siskiyou County Agricultural Commissioner, for the use of Transform CA (sulfoxaflor) (EPA Reg. No. 62719-727) to control the blue alfalfa aphid on alfalfa.

WORKER HEALTH AND SAFETY BRANCH

<u>Respiratory Protection</u>: On July 14, at the request of Nan Singhasemanon, Emma Colson created a comprehensive review of federal and state guidelines for dealing with filtering facepiece respirator extended use or reuse, use beyond the shelf life, and non-NIOSH approved filtering facepiece use.

COVID-19 Health and Safety Protocol for License Exams: On July 14, Robert Ford developed COVID-19 health and safety protocols for the Pest Management and Licensing Branch to use when conducting licensing examinations for the regulated public.

Chilean Fruit Air Monitoring (CFAM) Program: On July 15, Emma Colson participated in a conference call with stakeholders to determine the status of the 2020 Annual CFAM kickoff meeting held in Long Beach. This meeting is held the first Thursday of November (just before Chilean grape importation season) and is attended by roughly 50 stakeholders and representatives from state and county agencies. Given the current COVID-19 crisis, the meeting may either be canceled or moved to a virtual platform.

<u>Pesticide Applicators Professional Association (PAPA)</u>: On July 15, Emma Colson gave a presentation on PPE requirements at a PAPA webinar.

<u>Radio Indígena Recorded Interview</u>: On July 21, Alex Cadenas participated in a recorded Facebook live Q&A session with Radio Indígena (Mixteco Indigena Community Organizing Project-MICOP). Alex received the invitation to participate from Xitlalic Martinez of the Employment

Development Department. Worker Health & Safety (WHS) has worked with Radio Indígena in the past and they provide a great platform for reaching the non-English/Spanish speaking farm worker community in the Ventura County area. Topics included promoting the CASPIR mobile app, promoting documents in Spanish (safety guides), promoting Spanish video content on YouTube, sanitizer safety, and an update on how County Agricultural Commissioners are distributing safety masks to farm workers.

<u>Pesticide Applicators Professional Association (PAPA)</u>: On July 29, Emma Colson gave a presentation on respiratory protection at a PAPA webinar.

Current Issues in the Assessment of Respiratory Protective Devices: Non-Traditional Workers and Public Use Workshop: On August 4 - 5, Emma Colson attended the virtual workshop hosted by The National Academies of Sciences Engineering and Medicine in partnership with NIOSH and the National Personal Protective Technology Laboratory. The workshop focused on finding solutions for workers who incidentally wear respirators as well as discussions on public standards for respiratory protection.

<u>Providers Meeting</u>: On August 10, Martha Sanchez will be participating at the Sacramento Mexican Consulate Providers Meeting. The goal of the meeting is to provide updates on Covid-19 related issues and how we can assist our community and our fieldworkers.

<u>EJ Pesticide Workshop - Tulare</u>: On October 6 and 7, DPR, the Tulare and the Central California Environmental Justice Network (CCEJN) will be teaming up to present the 7th Environmental Justice Pesticide Workshop. The two-day workshop is an opportunity for community leaders and stakeholders to learn about DPRs and the Tulare CAC programs when protecting workers, the community and the environment.

DPR LEGISLATIVE NEWS

The Assembly and Senate reconvened on July 27, 2020 to continue the second year of this year's legislative session. The Legislature Bills of interest include:

AB 1672 (Bloom) Solid waste: premoistened nonwoven disposable wipes—This bill would require, except as provided, certain premoistened nonwoven disposable wipes manufactured on or after January 1, 2022, to be labeled clearly and conspicuously with the phrase "Do Not Flush" and a related symbol. The bill would also prohibit a covered entity, as defined, from making a representation about the flushable attributes, benefits, performance, or efficacy of those premoistened nonwoven disposable wipes and would establish, until January 1, 2026, the California Consumer Education and Outreach Program, under which covered entities would be required to participate in a collection study conducted in collaboration with wastewater agencies for the purpose of gaining understanding of consumer behavior regarding the flushing of premoistened nonwoven disposable wipes and to conduct a comprehensive multimedia education and outreach program in the state.

AB 1788 (Bloom) Pesticides: use of anticoagulants - Current law regulates the use of pesticides and authorizes the Director of DPR to adopt regulations to govern the possession, sale, or use of any pesticide. Existing law prohibits the use of any pesticide that contains one or more of specified anticoagulants in wildlife habitat areas. Current law exempts from this prohibition the use of these pesticides for agricultural activities. Current law requires the director, and each county agricultural commissioner under the direction and supervision of the director, to enforce the provisions regulating the use of pesticides. A violation of these provisions is a misdemeanor. This bill would expand this prohibition to the entire state.

AB 3220 (ESTM) pesticide poisoning

Existing law, until January 1, 2021, requires an employer to contract with a medical supervisor registered with the Office of Environmental Health Hazard Assessment to satisfy the employer's responsibilities for medical supervision of employees who regularly handle pesticides, as provided. Until January 1, 2021, existing law requires a laboratory that performs tests ordered by a medical supervisor to report specified information to the Department of Pesticide Regulation. This bill would extend these requirements to January 1, 2023.

SB 86 (Durazo) Public health: pesticide: chlorpyrifos

Would, beginning with the first quarter of 2021, require the Department of Pesticide Regulation to prepare and submit to certain Senate and Assembly committees and the California Surgeon General quarterly reports containing information, as prescribed, regarding granular chlorpyrifos use, monitoring, and exposure during the quarter.

SB 964 (Skinner) Chemicals: outdoor applications: residential areas

Would require a government agency or an entity with which a government agency contracts to submit a plan for the application of a chemical to the Office of Environmental Health Hazard Assessment before applying the chemical outdoors in a residential area, defined as a residential neighborhood, school, daycare center, park and recreational facility, or other location where infants and children generally spend time. The bill would require the office to conduct an independent review of any health impacts of the chemical, including reviewing any relevant scientific literature, studies, or other independently peer-reviewed information relating to the chemical's adverse health effects on infants and children.

COUNTY LIASION/LICENSING

Oral Exams for Commissioner, Sealer, and Deputies. The results of the last oral exam cycle are:

Inspector Exams. On-line inspector exams will continue to be available on a monthly basis to counties with the ability to administer them. A few counties administered paper inspector exams at the beginning of July. The results of that paper exam cycle have been released.

Written Exams for Commissioner, Sealer, and Deputies. The written exams for Commissioner, Sealer, and Deputies exams will be administered the week of August 31st.

License Renewal Project. The County Licensing Program has hired back retired annuitant, Merry Wells, to work on a project to renew all the licenses of active county staff over the next 4 – 6 months. The first focus will be on upper license holders. We wish to solicit your help to verify your active county staff compared to our current list. Once the project is set to begin, we will send out a spreadsheet with a list of employees to be verified. More details will be forthcoming soon.

CROP REPORT DATA

Milk Production Data. At the CACASA Interim Board of Directors meeting, it was decided that counties would report the milk production estimates provided by USDA-NASS in their annual crop reports. Because no other sources of milk production data are available, barring an individual county survey, this approach was recommended by the large milk production counties of the San Joaquin Valley for consistency. USDA-NASS has released their estimates, via email, to the following 17 counties: Fresno, Glenn, Humboldt, Kern, Kings, Madera, Marin, Merced, Riverside, Sacramento, San Bernardino, San Joaquin, Sonoma, Stanislaus, and Tulare. Environmental Projects. The Appellations of Origins rulemaking process completed its public comment period on May 6, 2020 and CDFA staff are now in the final phase of analyzing the public comments received. The proposed regulations for the Appellations of Origins could potentially be amended based on the analysis of the public comments. The appellations webpage is: https://www.cdfa.ca.gov/calcannabis/appellations.html.

The public comment period for the proposed regulations for the OCal Program, a statewide certification program that will establish and enforce comparable-to-organic cannabis standards, ended on July 7, 2020. Minor changes to the text are being made by program staff, which will require another 15-day public comment period. Immediately following the rulemaking process and on or before January 1, 2021, the program will begin accepting applications for certifying agent accreditation and/or registration. Once they've been accredited and/or registered, certifying agents may begin certifying. These documents can be found at: https://www.cdfa.ca.gov/calcannabis/regulations.html.

OCal Certifying Consultant RFP. CalCannabis has released an RFP for a consultant to assist the OCal Program with establishing an enforcement program and accreditation process that fulfills its statutory direction to be comparable to the National Organic Program (NOP). Track-and-Trace, aka California Cannabis Track and Trace (CCTT). Currently, there are 151 credentialed State users and 8,965 credentialed licensed users in the CCTT-Metrc system. The CCTT-Admin team continues to work with Metrc to credential new annual and provisional licensees and State users daily. The CCTT-Admin continues to work with the Compliance and Enforcement Branch to transition regulatory responsibilities back to the Enforcement Section. FAQs, which include contact information for Metric, can be found at: https://www.cdfa.ca.gov/calcannabis/cctt.html.

Compliance and Enforcement Branch (CEB). CEB will begin initial CCTT inspections at licensed sites. CEB continues to participate in enforcement of unlicensed commercial cannabis operations with law enforcement partners across the state. CEB has participated in more than 65 enforcement actions to date.

Site inspections continue to be conducted by counties under contract and CDFA staff throughout the state. Staff are verifying compliance with license requirements and issuing follow up documentation for fixing non-compliances. County contracts have either been extended, renewed, or amend to account for delays inspections due to COVID-19.

MEASUREMENT STANDARDS

County Agreements. Fiscal Year (FY) 2020/21 County Agreements for Weighmaster and Fuels, Lubricants, and Automotive Products Programs have been sent electronically to each county for review and signature. Please follow the directions provided in the email sent from Carrie James, CDFA Office of Grants Administration. NOTE: Activities may begin under the new agreement but will not be reimbursed until the FY 2020/21 agreement has been fully executed.

EMV Liability Compliance Delay. The National Association of Convenience Stores' news publication (EMV Compliance) has an article stating that Discover, American Express, and VISA are again postponing their liability compliance with the Europay, Mastercard, and VISA (EMV) deadline for payment card "chip readers" in retail motor fuel dispensers (RMFDs) from mid-October 2020 to mid-April 2021. The reasons cited in the article EMV Compliance are economic and operational challenges driven by COVID-19. This means that the financial liability for payment card fraud committed through RMFDs remains the responsibility of the issuing financial institution (i.e., Discover, American Express, and VISA), not the retailer, until the new deadline. DMS has not been made aware of other financial payment card institutions delaying their compliance with EMV liability from mid-October 2020.

County of Origin Labeling (COOL) Program. DMS has a contract with the United States Department of Agriculture (USDA) Agricultural Marketing Service to conduct annual COOL seasonal audits of defined grocery stores and club markets to help ensure that specified commodities and labeling meet federal requirements. COOL staff are being hired and trained and anticipate auditing to begin by mid-August. This is strictly a federal program and no "ride-alongs" or sharing of federal audit materials are permitted. DMS Operations During the Coronavirus (COVID-19) Pandemic. The COVID-19 pandemic has seriously impacted business operations and people's personal lives. CDFA and DMS are deemed an essential function to protect California's food supply. To this end, DMS will continue to support the county sealers and conduct certain weights and measures functions. For further details, please refer to DMS Notice G - 20 - 03.

Temporary Closure of DMS Anaheim Field Office. DMS' Anaheim facility remodel is nearing completion. Pending review by State Fire Marshall, we are on schedule to move back into the building on August 10, 2020. Reinstalling laboratory equipment, instrument calibrations, and system check outs will require a few additional weeks. The Sacramento fuels lab will process samples normally delivered to Anaheim during the remodel. To process complaint samples, contact the DMS Petroleum investigator. There is no scheduled change for the field staff in the Weighmaster, Device, and Petroleum programs.

Revision: County Monthly Reports (CMRs) and County Annual Reports (CARs). Business and Professions Code section 12102 requires the Department to submit its annual report (CAR) to the Governor and the Legislature prior to each regular session. The Department has been unable to meet this mandate in recent years due to several counties' late submissions. California Code of Regulations (CCR) section 4087(a) states, "Each county shall report annually, before November 1, expenditures for the prior fiscal year, which shall be the period from July 1 through June 30." Beginning this year, DMS will exercise its right under CCR section 4087(c) to withhold payment to a county that does not submit CAR data by November 1.

Pest Detection/Emergency Projects – Summary through July 31st 2020 Projects

- Oriental Fruit Fly Group (Bactrocera dorsalis group) 4 adults.
 Delimitation trapping is ongoing in response to the detection of a single adult in Newport Beach (Orange Co.).
- Gypsy Moth (*Lymantria dispar*) 1 adult.
 Delimitation trapping is ongoing in response to the detection of a single adult in Foresthill (Placer Co.).
- Asian Gypsy Moth (Lymantria dispar asiatica) 1 adult.
 Delimitation trapping is ongoing in response to the detection of a single adult in Sunnyvale (Santa Clara Co.).
- Japanese Beetle (*Popillia japonica*) 93 adults.
 Delimitation trapping is ongoing in response to the detection of 65 beetles in Rancho Cordova and 28 beetles in Sacramento (Sacramento County).

Japanese Beetle High Hazard Program: 11 beetles have been trapped in high hazard traps around airports and freight forward facilities in Los Angeles, Riverside, Sacramento, San Bernardino, San Diego and Yolo counties. 165 beetles have been found on cargo planes originating in the eastern U.S. when inspected at arrival in California (Alameda, Los Angeles, Sacramento, San Bernardino, San Diego and San Joaquin counties).

Electronic Trap Record System (CalTrap)

INDUSTRIAL HEMP

- **CDFA Emergency Regulations.** The emergency regulations for sampling, testing, harvest, and destruction have been extended for additional 120 days by the Governor's Executive Orders. The emergency rulemaking has been extended until October 20, 2020.
- CDFA Permanent Regulations. The Department of Finance provided feedback regarding the proposed permanent regulations pertaining to sampling and testing for THC content, which will require CDFA to develop a Standardized Regulatory Impact Assessment (SRIA) as part of the rulemaking. CDFA will make a public announcement when the SRIA and additional proposed changes are available for public comment. Rulemaking documents can be found at: https://www.cdfa.ca.gov/plant/industrialhemp/ih-regulations.html.

<u>State Plan</u>: CDFA routed and approved language for a state plan. This language had to be sent to the Attorney General's office for their review and approval and is now with the Governor's Office for approval. Once that review is completed, CDFA will be able to official submit and share that language. Program staff have been having informal conversations with USDA regarding the proposed language for the state plan.

County Contracts. Invoices for the FY 19/20 agreements are currently being processed and payments should be trickling out to the counties soon. Agreements for the next two fiscal years (FY 2020/2021) have been sent out to the counties for approval.

PIERCE'S DISEASE CONTROL PROGRAM

Pierce's Disease Winegrape Assessment Rate. The PD/GWSS Board voted during its July 7 meeting to set the Pierce's disease winegrape assessment at \$1.00 per \$1,000 of value for the 2020 harvest; the same rate as last year. The Board's recommendation was approved by CDFA Secretary Karen Ross. Assessment funds are used for research and outreach on Pierce's disease, glassy-winged sharpshooter, and other designated pests and diseases, including European grapevine moth, mealybugs, brown marmorated stink bug, red blotch virus, fanleaf virus, leafroll virus, and the recently designated spotted lanternfly.

GWSS Adult Trapped in Alameda County. Alameda County is conducting a delimitation in the city of Fremont after a GWSS was trapped in an urban/residential area on July 23, 2020. Visual survey of the area has been completed and additional traps are being monitored. No additional finds have been detected to date.

Delimitation Surveys Ongoing in Madera County. Madera County continues with delimitations in several areas of the county where GWSS has been detected. Potential treatment activities are being evaluated but have not been implemented to date.

ANIMAL HEALTH AND FOOD SAFETY SERVICES

Wildlife Services. It is anticipated that the CEQA Notice of Preparation/NEPA Notice of Intent will be announced in September 2020. Scoping meetings and public hearing are anticipated to follow during the fall.

Rabbit Hemorrhagic Disease. CDFA is currently supporting CDFW in the investigation of rabbit hemorrhagic disease in wild rabbits. Additionally, one case was detected in a domestic rabbit in San Bernardino County. About 30 veterinarians have received a vaccine for the disease. California Avian Health Education Network. As a result of the most recent outbreak of vND in S. CA. and to prevent more in the future, CDFA established California Avian Health Education Network (CAHEN). This program is dedicated to offering education, training, outreach, testing,

and vaccination options for backyard poultry flock owners, other bird enthusiasts, stakeholders, and everyone dedicated to avian health in Southern California. By working together, CDFA, USDA, University of California extension groups and community partners aim to keep California free of foreign animal diseases to prevent similar devastation in the future. INSPECTION SERVICES

Direct Marketing District Supervisor Change. The Northern District Supervisor of our Direct Marketing Program, Danielle Goin, will be leaving CDFA mid-September 2020. LEGISLATION

- Assembly Bill 228. (Aguiar-Curry/Wilks) This bill would require a manufacturer of food that includes industrial hemp to be able to demonstrate that all parts of the plant used in their food come from a federally approved industrial hemp program and restrict distribution, labeling, and marketing of hemp material. Broad conversations are occurring to see what vehicle is available for hemp issues this session.
- Senate Bill 864. (Wilk) This bill will require CDFA to report production/licensing statistics to USDA-FSA, require laboratory tests to include the measurement of uncertainty of THC test results, and require laboratories to use validated testing activities with measurement of uncertainty. Broad conversations are occurring to see what vehicle is available for hemp issues this session.
- Assembly Bill 2250. (Carrillo) This bill will remove a part of the restriction imposed on a county of the first class regarding the percentage of employees provided protections as permanent employees under the county's civil service system as related to CDFA contracts. *Appears stuck in committee and not moving forward.*
- **Senate Bill 1429. (Monning)** This bill will amend the Fish and Game Code to impose penalties on cultivators of industrial hemp that violate specified provisions of the law generally protecting fish and wildlife, water, or other natural resources. The current law applies to only cannabis growers. **Appears won't move forward per author**.



CACASA Executive Report August 2020

<u>President & Executive Director Report – Josh Huntsinger & Sandy Elles</u>

- **Board Updates –** The Board approval several actions during the Summer Interim Board meeting:
 - Approved contracting with Bill.com for Accounts Payable processing, pending final discussions with the vendor.
 - Approved a two-year contract renewal with Calico for website maintenance and support.
 - Approved Life Awards for Fred Crowder and Tony Linegar.
 - Approved cancelling our contract with the Holiday Inn for the Fall Conference and shifting to a virtual conference.
- COVID-19 Updates CACs continue to work with our state partners in securing and distributing PPE supplies, and in helping to provide isolation housing options for ag workers. Federal and state funds are available to assist with setting up Housing for Harvest programs, which provide temporary hotel housing for farm and food processing employees that must isolate due to COVID-19, but are unable



 $\begin{tabular}{ll} Housing for the \\ to do so at home. \end{tabular}$

Research is continuing on options for CACASA and counties to collaborate with partners and provide additional options for online CE classes for DPR licensees.

- CSAC Institute's COVID-19 Pandemic Leadership Resources Check out the CSAC webpage of
 resources for leading during times of crisis. The website includes an excellent collection of on-demand
 webinars and additional resources regarding virtual meetings and ways to cope with the technical and
 adaptive challenges of operating through a pandemic.
- Industrial Hemp Updates CDFA is still working on the CA State Hemp plan and working with USDA AMS on the plan specifics.
 - Unfortunately, SB 864, the Industrial Hemp bill authored by SB-864 by Sen. Wilk, is dead for this legislative session. The bill included several items to bring CA laws into compliance with federal hemp regulations. There may be an opportunity to amend those provisions into other bills this month.
- UGT 5-Year Implementation Plan CACASA met with staff from CDFA's Plant Health Division on Aug. 10th to discuss UGT funding for Pest and Disease Research funding. CDFA outlined several research projects including: development of a Master Gardeners Citizen Science Sentinel Detection project for Spotted Lantern Fly and Pink Hibiscus Mealybug; Analysis and Recommendations for the Statewide Pest Detection Grid; Imidacloprid and Malathion Alternatives research. CDFA agreed with CACASA's desire to analyze our current pest exclusion program and update of the 1997 Rogers Study. We will meet again after CDFA has the research contract costs.
- Congrats to Val Dolcini on DPR Director Appointment On August 5th, Director Dolcini appeared (virtually) before the Senate Rules Committee for his confirmation hearing. After a brief Q&A and comments from the public, the Committee unanimously approved the appointment. All of the comments were supportive, reflecting diverse support from ag industries (CA Citrus Mutual, CA Ag Council, Community Alliance of Family farms), Pest Control Operators of CA, environmental justice groups, and conservation organizations.

• **Legislative Updates** – The legislature resumed on August 3rd, with limited access by the public allowed. As the compressed legislative cycle continues CACASA continues to monitor bills of interest.

- QC Funding Request and Sustainable Weights & Measures Advocacy Project CACASA's effort for \$3 M in state funding for the Quantity Control programs is temporarily sidelined by the COVID-19 health crisis and financial drain on state revenues and reserves. A new strategy to determine how to move forward will be devised.
 - As recommended by the W&Ms committees, CACASA will remain neutral on the DMS proposal to raise device fees for metrology.
- California County Activity Tracking System (CalCATS) Counties continue to work with Calico in
 implementing the new CalCATS program. Preliminary feedback indicates the system was not "shelf
 ready" at the initial launch https://calcats.org.
- CalPEATS Mobile Device Funds for pesticide use enforcement tablets are available. Some
 counties have remaining funds from their original allocation. A small amount of funding is available
 for counties if they have added a PUE Inspector. As originally intended, replacement of tablets is the
 financial responsibility of each county.
- CACASA Outreach materials Every county was sent a package of CACASA brochures and rack
 cards, using about half of our printed supply. If you need more or did not receive your package, please
 let me know. Most counties also received CACASA logoed face mask. The remaining counties will
 receive their face mask when more supplies are received.
- CalTrap Updates Progress continues with the CalTrap app development with Milestones 1, 2, 3 and 4 completed. Delays were experienced with the USDA IPHIS interface and cloud hosting, but the Steering Committee is now launching user acceptance testing.
- Neonicotinoids Draft Regulations CACASA met with DPR staff on August 6th to discuss the proposed regulations and upcoming webinars to gather public comment before the formal rulemaking. The draft rules are crop specific and complex, and grouped in a tiered approach based on the crops' attractiveness to bees. We will meet again with DPR after the webinars to continue the discussion. Please encourage growers and UCCE specialist in your county to review the draft regulations and provide input to DPR during this early phase of the rulemaking process, as DPR's general intent is to allow continued use of all 4 neonic products (clothianidin, dinotefuran, imidacloprid, and thiamethoxam). - 2. Attached is distribution criteria for these masks, please read. In short, masks for smoke are for outdoor ag workers working when the AQI reaches 151. Masks for pesticide usage has the same criteria as before.
- 3. **Number Tracking is extremely crucial and involved!** The Governors Office wants daily tracking (which I admit is hard). He would like to know how many masks are distributed each day that I then have to report up the chain of command.
- 4. Please continue to track the recipients by name, company or type of entity, quantity distributed and contact information if possible.

I apologize for the reporting parameters being imposed on you all. These masks are a blessing, but are coming with lots of scrutiny from the Governor's Office, Legislature, OES, etc.

To add on to what Hyrum asked, I would add that we as Agricultural Commissioners are in a unique position to help share information with our Farm Labor Contractors. Their mandatory annual county registration provides us with a great opportunity to assist the state in getting the word out to this industry, which is very much in the public eye right now.

You may want to consider in your guidance to FLCs to tell them to add these to their mandatory postings area and include them as paycheck stuffers. Suggest they provide them in paychecks at least once a month, to ensure employees continue to understand the importance of following the

protocol. Keep in mind that FLCs have to pay workers on a weekly basis, so they have ample opportunities to provide reminder communication. The more specific the recommendation, the better.

New Report Lays Groundwork for Safer, Moresustainable Alternatives to Banned Pesticide Chlorpyrifos

A report issued today identifies alternatives for California growers to the banned pesticide chlorpyrifos and calls for continued work towards safer, more sustainable pest management practices.

Following California's historic decision to end use of the pesticide chlorpyrifos in 2019, the <u>California Department of Pesticide Regulation</u> (DPR) and the <u>California Department of Food and Agriculture</u> (CDFA) convened the <u>Alternatives to Chlorpyrifos Work Group</u> to evaluate potential alternatives. The work group's <u>report</u> outlines actions that can further support agriculture and the health of local communities, farmworkers and the environment.

"This report highlights current alternatives to chlorpyrifos, but it also underscores the need to continue our combined efforts to provide safer and more sustainable crop protection tools to California's farmers," said DPR Director Val Dolcini. "Working with community organizations, other agencies, agricultural producers, and UC scientists, we

will continue our work to develop a roadmap that can be used by all Californians to manage pests more safely and sustainably."

"Partnerships will be key as we move forward with economic recovery," said CDFA Secretary Karen Ross. "We need collaboration to implement this ambitious roadmap and deliver innovative, pragmatic solutions to the complex array of issues farmers and the ag workforce confront every day as they strive to produce high-quality agricultural crops to meet consumer expectations."

The report, <u>Towards Safer and More Sustainable Alternatives to Chlorpyrifos: An Action Plan for California</u>, identifies:

- Nonchemical and synthetic alternatives for growers and the relative toxicities of the alternative pesticides.
- <u>Biopesticides alternatives to chlorpyrifos</u> derived from natural materials.
- A five-year action plan to strategically manage pests using safer, less-toxic alternatives.

"California leads the nation in advancing more sustainable pest management practices, and this report makes clear the need to continue that important work," said Jared Blumenfeld, California Secretary for Environmental Protection. "The Governor's 2020-2021 Budget contains funding that will allow DPR and CDFA to continue this dialogue and build on the momentum begun by the Chlorpyrifos Alternatives Work Group."

DPR and CDFA plan to convene a successor group this year to focus on system-wide safe, sustainable pest management practices.

The Work Group included a wide cross-section of leaders and experts – including representatives from agricultural organizations, scientists focused on pest management and public health, environmental justice groups, farmworker advocates, and pest control advisors. Over the course of five months, the group conducted three statewide public roundtable discussions and received extensive public input during.

Subject: Distribution Criteria for N-95 Respirators Supplied by CalOES

The N-95 respirators provided by the state to County Agricultural Commissioners are designed to protect farmworkers and the agricultural workers that support the essential function of the food supply. The approved uses for the N-95 respirators are for protection from wildfire smoke while working outside according to Cal OSHA requirements and for workers who handle/apply pesticides in accordance with Department of Pesticide Regulation (DPR) requirements. We want to assure that the N-95s are appropriately distributed as intended because of the high demand during this COVID pandemic. Distribution of this PPE is closely monitored to make sure they are appropriately distributed to workers.

In order to facilitate proper, consistent distribution of N-95 respirators we are providing the following criteria for eligible distribution:

Wildfire Smoke:

- Agricultural businesses that have outdoor farmworkers in smoke-impacted regions. Intended use is for farmworkers or agricultural workers that support the food supply.
- For use during outdoor work when the Air Quality Index for particulate matter 2.5 reaches 151 or higher and employers are unable to find alternative mitigation measures listed in the following: https://www.dir.ca.gov/DIRNews/2020/2020-71.html
- Distribute a maximum 5 per outdoor employee (assume 5 per exposed worker to be used on alternate days for a 10-day wildfire event).

Pesticide Handling/Application:

- Businesses that apply pesticides for the production of an agricultural commodity.
- Business must have an operator ID, restricted materials permit number, or be registered with the County Agricultural Commissioner as an agricultural pest control business.
- Distribution of N-95 respirators are for protection of agricultural pesticide applicators and handlers against pesticide exposure as required by specific product.
- Respirators are for farmworker protection while using a pesticide and resale is prohibited.

Monitoring and Reporting:

- Upon receipt, send CDFA the date of arrival and number of N-95 respirators received.
- Track distribution of respirators by company name, contact information, date distributed, and number of respirators distributed.
- Each day send an update on number of respirators distributed to CDFA for the following day.

Hi Ed,

I was talking to Doug about using the trailer and he brings up a good point. The fork lift will only be able set the pallets on the very rear of the orange trailer but can't scoot it far enough forward to center the weight over the axle. Likewise, the tailgate of any of our pickup trucks will be in the way of the fork lift scooting the pallets far enough forward into the bed of the truck to be centered over the axle. We think the best option would be to use a second pickup to pull the second black trailer and those can be loaded nice and easy from the rear since they don't have a tailgate or wall of any kind. We have enough heavy duty straps to cover both trailers so we would only need a second large vehicle. The smaller fuel truck here in Cordelia has a hitch. So does Chandler's truck or Adam's truck.

Solano Farmers and Ranchers,

Cal OES and CDFA have supplied the Solano Agriculture Department with N95 respirators to distribute to local agricultural workers for wildlife smoke protection and pesticide use safety.

Because N95s are in high demand due to the COVID pandemic we are required to adhere to the following criteria for eligible distribution:

Wildfire Smoke:

- Agricultural businesses that have outdoor farmworkers in smoke-impacted regions. Intended use is for farmworkers or agricultural workers that support the food supply.
- For use during outdoor work when the Air Quality Index for particulate matter 2.5 reaches 151 or higher and employers are unable to find alternative mitigation measures listed in the following: https://www.dir.ca.gov/DIRNews/2020/2020-71.html
- Distribute a maximum 5 per outdoor employee (assume 5 per exposed worker to be used on alternate days for a 10-day wildfire event).

Pesticide Handling/Application:

- Businesses that apply pesticides for the production of an agricultural commodity.
- Business must have an operator ID, restricted materials permit number, or be registered with the County Agricultural Commissioner as an agricultural pest control business.
- Distribution of N-95 respirators are for protection of agricultural pesticide applicators and handlers against pesticide exposure as required by specific product.
- Respirators are for farmworker protection while using a pesticide and resale is prohibited.

Here's a description of the Latinx Planning Committee and some of things we're working on:

The Latinx Planning Committee was formed as part of a broader effort to advance racial equity in Solano County grounded in the <u>Government Alliance on Race & Equity</u> framework: Normalize, Organize, Operationalize. The committee plans and hosts quarterly town-hall style "caucus" events focused on developing cross-departmental strategies for outreach and service delivery to underserved communities, and in alignment with the departmental values of equity and diversity, utilizing in-reach strategies to retain a diverse and inclusive workforce at all levels of the organization.

In May, the group hosted an engaging "Latinx Equity & COVID-19 Virtual Townhall" involving an overview of data on COVID-19 disparities among the Latinx community, and strategies around improving outreach, connection to resources, and information dissemination for Latinx communities

in Solano.

Since then, the planning committee has been sharing resources related to Latinx communities & COVID-19, and recently created culturally relevant health education materials designed specifically to reach the Latinx population in both English and Spanish. Housing for the Harvest is a new program that will offer temporary hotel housing to agricultural workers who need to isolate due to COVID-19. It will help positive or exposed workers protect their loved ones and coworkers by giving them a space to self-isolate.

More information is available at this site: https://covid19.ca.gov/housing-for-agricultural-workers/

The State will book hotel rooms in participating counties for workers who need to self-isolate for up to 14 days. The State will coordinate with local administrators who manage the program.

Locally-funded administrators will:

- serve as primary point of contact with workers who need isolation housing
- verify participant eligibility
- coordinate with the State to book rooms
- provide services at the hotel site including transportation, meals and wellness checks
- ensure services are provided in the participant's language, and
- collect data required for FEMA reimbursement.

Local administrators will be identified in coordination with the State government. They may be a county or city agency, tribe, non-profit organization, or a philanthropic organization.

Hotel booking links and more details are coming soon.

Initial efforts will focus on the Central Valley, Central Coast, and Imperial Valley regions. These are the regions with the highest number of agricultural workers. It would expand as other counties or regions with this population opt in.
